# SECTION I: INVITATION FOR BIDS

## 1. Preparation of Bids

You are requested to quote for the services mentioned in section III, by completing, signing, and returning:

- (a) the Bid Letter in Section II with its annex for Bid Securing Declaration,
- (b) the Priced Activity Schedule in Section IV,
- (c) the Specifications and Performance Standards in Section V, and
- (d) any other attachment as deemed appropriate.

You are advised to carefully read the complete Invitation for Bids document, including the Contract Data Sheet in Section VII, before preparing your bid. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

## 2. Documents to be Submitted

Bidders shall submit along with their bid:

- (a) a company profile, experience and evidence of similar services provided and customers' reference details, and
- (b) an indication of wide broadcast of TV, radio, and other broadcasting related services in various locations in Namibia and outside Namibia, if applicable.

## 3. Validity of Bids

The Bid validity required is 90 days from the date of submission deadline.

## 4. Contract Period for Services

The contract shall be for a period of three (3) years with fixed rates for an initial period of 12 months with new rates to be submitted on an annual basis. The bidder is required to provide NHE with a new rate card at the beginning of each year for a period of three (3) years or at any other period when there are changes in the bidder's prices.

## 5. Sealing and Marking of Bids

Bids should be sealed in a single envelope, clearly marked with the Procurement Reference Number, and addressed to NHE with the Bidder's name at the back of the envelope.

## 6. Submission of Bids

Bids should be deposited in the Bid Box located at **NHE Head Office Eros** on or before **31 May 2024 @ 10H00**.

Bidder is advised to submit the bid at their earliest possible time. Early submission will expedite the award process because the bid does not involve any competition.

Late submissions will be rejected. Bids received by fax or e-mail will not be considered.

## 7. Opening of Bids

There will not be a bid opening reading. Bids will be opened and evaluated internally by NHE.

## 8. Evaluation of Bids

The Public Entity shall have the right to request for clarifications during evaluation.

Bidders are requested to submit along with their bid:

- (a) a company profile, experience and evidence of similar services provided and customers' references details.
- (b) an indication of wide tv, radio and other broadcasting related services in various locations in Namibia and outside Namibia, if applicable.
- (c) proof of registration/licence with the Communication Regulatory Authority of Namibia (CRAN). This is a mandatory requirement for tv and radio broadcasting services and failure to submit will result in disqualification.
- (d) the bid is restricted to companies known for providing tv, radio, and other broadcasting related services based in Namibia.
- (e) technical evaluation of this bid will be based on the information required in paragraph (a) to (d) above. Failure to submit a full information may result in your bid being disregarded.

## **9. Financial Evaluation**

- (a) The Financial Evaluation shall be based on the bidder's rate card / tariffs schedule for the current financial year to be submitted together with the bid.
- (b) Bidders will be required to submit a new rate card / tariff schedule at the beginning of each year or at any other period when there are changes in the bidder's price. Failure to submit new rate card/tariff schedule will result in no price changes.
- (c) The submission of the rate cards/tariff schedule shall be for a period of three (3) years, thereafter NHE will invite new bids.
- (d) Failure to submit a rate card/tariff schedule may result in your bid being disregarded.

## **10. Eligibility Criteria**

- a) A bidder that is under a declaration of ineligibility by the Government of Namibia in accordance with applicable laws at the date of the deadline for bid submission and thereafter shall be disqualified,
- b) Bids from bidders appearing on the ineligibility lists of African Development Bank, Asian Development Bank, European Bank for Reconstruction and Development, Inter-American Development Bank Group and World Bank Group shall be rejected.
- c) Bidders should submit a statement on past and present declaration of ineligibility, if any, by any local/international agency or any termination of contract for unsuccessful completion of assignment, giving adequate details to enable a fair assessment.

## **11. Mandatory Requirements**

For the bid to meet the mandatory requirements, the bidder must submit the following documents as outlined in section 50 of the Act:

- a) an original or certified copy of a valid certificate of good standing with the Receiver of Revenue.
- b) a valid certificate of good standing with the Social Security Commission or, in the case where a company has no employees, confirmation letter from the Social Security Commission.
- c) as required by the Affirmative Action (Employment) Act, 1998 (Act No. 29 of 1998) -
  - (i) a certified copy of a valid affirmative action compliance certificate issued under section 41 of that Act.
  - (ii) a certified copy of an exemption issued under section 42 of that Act, or
  - (iii) a certified copy of proof from the Employment Equity Commissioner that

the Consultant or supplier is not a relevant employer as defined in that Act.

- d) a written undertaking as contemplated in section 138(2) of the Labour Act, 2007(Act No. 11 of 2007), and
- e) a certified copy of a valid –
  - (i) certificate of business registration for an entity incorporated or registered under the company or close corporation laws of Namibia.
  - (ii) certificate of registration of a co-operative registered under the laws regulating co-operatives in Namibia.
  - (iii) document serving as evidence of registration as a trust and the trust deed for a trust registered under the laws regulating trusts in Namibia, or
  - (iv) partnership agreement in the case of a partnership, a valid joint venture agreement in the case of a joint venture or a valid agreement in case of other similar arrangements,

but a bidder or supplier who is a sole proprietor only needs to comply with the provisions of paragraph (a) to (d).

**NB!!** *Certification of documents should be done by a Commissioner of Oath appointed in terms of the Justices of the Peace and Commissioners of Oaths Act.1963 (Act No. 16 of 1963).

## **12. Technical Criteria**

The Specifications and Compliance Sheet details the minimum specifications of the services required. The services offered must meet these specifications, but no credit will be given for exceeding the specification.

## **13. Currency of Bid**

Bids shall be priced in Namibian Dollars and all payments will be made in this currency.

## **14. Bid Security/Bid-Securing Declaration**

Bidders are required to subscribe to a Bid Securing Declaration this procurement process.

## **15. Labour clause**

To qualify for award of the Contract, Bidders shall subscribe to the undertaking that the salaries and wages to be paid in respect of this bid are compliant with the relevant Laws, Remuneration Order and Award where applicable and that it will abide to the sub-clause 4.6 of the General Conditions of Contract if it is awarded the contract or part thereof.

## **16. Award of Contract**

The Bidder having submitted a bid that meets the following requirements will be considered for award for a period of three (3) years, on condition that a new rate card/tariff schedule is submitted at the beginning of each year or at any time when the bidder's prices changes

A bidder proving to be qualified to perform the service shall be selected for award of contract. Award of contract shall be by issue of a Purchase Order/Letter of Acceptance in accordance with terms and conditions contained in Section VI: Contract.

## **17. Notification of Award and Debriefing**

The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding

Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

Furthermore, The Purchaser shall promptly attend to all debriefing for the contract made in writing and within 30 days from the date of the publication of the award or date the unsuccessful bidders are informed about the award.

**18. Rights of Public Entity**

NHE reserves the right:

- (a) to split the contract as per the lowest evaluated cost per site, and
- (b) to accept or reject any bid or to cancel the bidding process and reject all bids at any time prior to contract award.
