SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

Namibia Qualifications Authority reserves the right:

- (a) to accept or reject any quotation; or
- (b) to cancel the quotation process and reject all quotations at any time prior to contract award.
- (c) Award per lowest evaluated line item

2. Preparation of Quotations

You are requested to quote for the services mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration, where applicable;
- (b) the Priced Activity Schedule in Section IV;
- (c) the Specifications and Performance Standards Compliance Sheet in Section V; and;
- (d) any other attachment as deemed appropriate.

You are advised to carefully read the complete Request for Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The quotation validity period shall be **30 days** from the date of bid submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should submit with your bid:

- (a) a valid certified copy of company Registration Certificate;
- (b) an original valid or certified copy of Good Standing Tax Certificate;
- (c) an original valid or certified copy of Good Standing Social Security Certificate;
- (d) a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- (e) a written undertaking as contemplated in section 138(2) of the Labour Act,
- (f) a certificate indicating SME Status (if an SME);
- (g) Submit a signed Bid-securing Declaration.
- (h) Submit a written undertaking as contemplated in section 138(2) of the Labour Act,2007 and Bid Security/Bid Securing Declaration

(i) Five (5) years experience in the provision of required services (attach documentary proof in the form of a reference letter from current and previous clients.

5. Services Completion Period

The completion period for services shall be within one (1) month after issue of letter of acceptance/issue of the Purchase Order. The starting date of the Head of Qualification is **01 July 2024.**

Bidders shall submit along with their quotation's documents and mandatory documents.

7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name at the back of the envelope.

8. Submission of Quotations

Quotations should be submitted in a bid box, situated at the Namibia Qualifications Authority, Head Office, Corner of Simeon Shixungileni, and Dr. W. Külz Street Windhoek not later than Friday,10 May 2024 at 10h00 am. Quotations by post or hand delivered should reach Namibia Qualifications Authority, situated at Corner of Simeon Shixungileni and Dr. W. Külz Street Windhoek by the same date and time at latest. Late quotations will be rejected.

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in section 9 above. A record of the Quotation Opening stating the name of the Bidders and the amount, the presence or absence of a Bid-Securing Declaration will be made available to any bidder on request within three working days of the Opening.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost to determine the lowest evaluated quotation.

12. Scope of Services, Specifications and Performance Standards

13. Prices and Currency of Payment

Prices for the execution of services shall be fixed in Namibian Dollars as quoted. Quotations shall cover all costs of labour, materials, equipment, overheads, profits and all associated costs for performing the services, and shall include all duties. The whole cost of performing the services shall be included in the items stated, and the cost of any incidental services shall be deemed to be included in the prices quoted.
